Biographical note

Max S. Wortman, Jr. received his Bachelor of Science degree (1956) in Civil Engineering from Iowa State University and his Doctor of Philosophy degree (1962) in Business Administration in the fields of Industrial Relations, Management, Labor Economics, and Statistics from the University of Minnesota. His dissertation was titled, "Some Influences of Membership in Employer Bargaining Associations Upon Manpower Management Functions in Industrial Organizations in a Local Labor Market." He attended a Case Method Program for Visiting Professors at Harvard Business School in the summer of 1965. He taught at Virginia Polytechnic Institute, the University of Massachusetts, the U. S. Navy Postgraduate School, and the University of Iowa (1962-1981). Wortman was the William B. Stokely chair in management (1981-1988) at the University of Tennessee. He was employed by the Iowa State University College of Business Administration (1988) and became a Distinguished Professor of Management at Iowa State University. He suddenly passed away in 2005.

Collection description

This collection contains meeting files, committee minutes, biographical information, manuscripts for publication, ISU course related records, consulting records, professional speeches and presentations, research files, and ISU Committee records.

The collection is organized into 10 series: **Series 1 – Academy of Management:** This series documents Wortman's involvement with the Academy of Management, and includes national and regional meeting information as well as division materials. Series 2 - Agribusiness Management: contains records relating to agribusiness management. Meeting minutes, committee records, conferences, seminars and symposiums document the work of the following organizations: the Institute of Certified Professional Managers: the International Agribusiness Management Association; and the Center for Agribusiness Management. **Series 3 – Biographical Information:** includes biographical information concerning Max S. Wortman, and also contains the filing system for his files. **Series 4 – Book Manuscripts**: contains Wortman's manuscripts for his published works, such as Personnel Management; Collective Bargaining; Management Cases; Administrative Policy; Emerging Concepts in Management; Women in Management; Strategic Management as well as ideas for potential books. Series 5 - Course Work Related Materials: contains syllabi and course readings for the following ISU courses: Management/Business Administration and Agribusiness Management. Series 6 - Management Development and **Counsulting:** contains a number of workshops and consulting projects. Of special interest is the Managerial Women in a Changing Society Program. Series 7 -Professional Talks and Presentations: documents Wortman's speeches and presentations throughout his career. The topics include: Japanese management styles, strategic management, professional academic development, women's issues, and

Potential: contains files on articles, either published or potentially publishable. The subjects include family-owned businesses, arbitration, collective bargaining, leadership behavior, managing human resources, anti-discrimination policies, gender issues in management, and communication. This series also contains Wortman's articles relating to personnel research. Series 9 – University (ISU) Related Committees: contains committee-related materials, including documentation on Vision 20/20, College of Business committees, Dept. of Management committees, as well as community groups such as the Ames Human Relations Commission and the Ames Commission on the Arts. Series 10 – Research Projects: contains research materials including information regarding energy, management training and economic education projects, in addition to information on the Kauffman foundation and international programs.
